### **Alternative Adoption Loans**

#### 401(k) Loans

Adoptive parents may borrow against their retirement account to pay for adoption. Many companies allow you to borrow up to 50% of the account value.

#### Home Equity Loans (Secured)

Parents of adoptive children who own their home and have equity may be able to obtain a loan to pay for their adoption.

#### Life Insurance Loans

If you have Life Insurance, some Life Insurance companies allow you to borrow against the cash value of your insurance for an adoption.

# **Potential Tax Credits**

Below are potential Tax Credits and Tax Relief for your adoption. Not all are guaranteed and some differ depending on your state of residence.

#### Adoption Tax Credit (www.irs.gov/taxtopics/tc607)

One of the largest sources of funds for adoptions is the Federal Hope for Children Act which provides an adoption tax credit. As of the year 2024, adoptive parents may be eligible for a tax credit up to \$16,810 per adoptive child with qualified expenses within the year of adoption. Visit their website for more details and check with your tax professional to see if this applies to you or your family.

#### **Child Tax Credit**

In addition to the Adoption Tax Credit for adoptive children, you may also be eligible for the federal Child Tax Credit. This credit can vary upon year, but as of 2024, there is a tax credit of \$2,000 for each child that qualifies under the age of 18. The child must be your dependent and must be a U.S. citizen.

#### State Tax Relief (www.taxsites.com/state)

Depending on your state of residence, most states offer a tax relief including tax credits, exemptions, or deductions. Check with your state's Department of Revenue or your tax professional for specific information on individual rules and requirements for each state.

#### Subsidies for Special Needs Children (https://www.cdss.ca.gov)

Adoption assistance or subsidies are payments made by a state or federal government to parents who adopt a special needs child. Check the website to see if your child qualifies.
